LDC is the statutory representative body providing advice on NHS dental services in Leicester, Leicestershire & Rutland to the East Midlands office of NHS England. The LDC enjoys a constructive relationship with officers and staff of the NHS England local team

Membership of the LDC enables local dental practitioners to represent the interests of dentists throughout LLR and to influence local NHS policies and practices.

I hereby give notice that the current terms of office of six of the existing LDC members are due to expire in September 2021, and an election is to be held to fill the resulting vacancies.

Details of the current membership, comprising both elected and co-opted (non-voting) members, are shown overleaf, for information.

1. The electorate includes all general dental performers in contract in Leicester, Leicestershire and Rutland
2. Nominations should be made by returning a completed nomination form to the address given **by no later than 12th June 2021**. Only nomination forms bearing original signatures will be valid. Forms must be signed by proposer, seconder and nominee.
3. In the event that fewer than 6 candidates are nominated, there will be a second circulation of the electorate by email. If more than 6 nominations, a postal ballot will be held.
4. If a ballot is to be held, short curricula vitae will be requested from the candidates.
